### Zone Deletes

Zone/Signal	Zone Type	Secondary	Zone Description – Note: Zone descriptions cannot exceed 20 characters in length.

### Notes:

Zone/Signals represent the actual Signal being received by the central station.

See Zone Type List for zone type options.

Secondary ONLY needs to be specified if you have a secondary account transmitter. Then please specify if the signal is coming from the secondary account transmitter.

Zone description is the description of the intrusion, fire, or trouble signal that you would like to have said to the subscriber or dispatch agency.

Dispatch process is up to 3 call types that you would like to have done with each signal, i.e. P, PD, L1, would mean call Premise to verify (if no cancel), Dispatch Police, Notify Call List 1.

If the account you are sending in is using Contact ID or SIA format, SAI will install default signal templates to supplement signals that are not defined by you. You may go to the SAI website to see a listing of SAI's default template for Contact ID or SIA formats. If signals specified by SAI default templates are not what you want done, specifying them on the zones form will override SAI's defaults.
